Educational Online course

J412 Optional Beam Connections: To Give or Not to Give is a video online course. The goal of this course is to train judges and coaches to recognize when elements are considered connected or not. There are three categories: Acro Connections, Dance Connections and Mixed Connections. Each connection will be shown once; then you must decide: connected, connected with tempo deduction or not connected. The correct answer will be shown with any applicable rationale. Each course will allow the judge to print a one-hour CPE (Continuing Professional Education) credit one time only. The course will take approximately one hour to complete.

NCAA PARTNERS WITH USA GYMNASTICS TO PROMOTE NCAA MEN'S and WOMEN'S CHAMPIONSHIP

INDIANAPOLIS --- The NCAA and USA Gymnastics have joined forces to showcase some of the nation's top gymnastics talent in mid-April. The NCAA hosts its 35th National Collegiate Women's Gymnastics Championship, April 15-16, at the Fort Worth Convention Center while USA Gymnastics holds its Region 3, Level 8 Championships at nearby Texas Christian University, April 14-16. The NCAA's 73rd National Collegiate Men's Gymnastics Championship is slated for April 15-16, in Columbus, Ohio at St. John Arena, at the same time as USA Gymnastics Region 5 Men's Junior Olympic Championship at The Ohio State University.

"What an exciting opportunity to partner with USA Gymnastics in the promotion of the NCAA Men's and Women's Gymnastics Championships as we collectively strive to grow the exposure of the sport while engaging youth within NCAA Championships," NCAA Director, Championships and Alliances Jeff Jarnecke said. "Our combined efforts will result in an unforgettable experience for both the youth regional participants and gymnastics fans."

"We welcome the opportunity to partner with the NCAA to promote the men's and women's national championships because these events are important to our gymnastics family and sport," Steve Penny, president and CEO of USA Gymnastics, said. "It's great to combine these prestigious events with USA Gymnastics Junior Olympic events. This allows the participants to watch the top college gymnasts compete at the national championships, which is a dream for many of our members. We hope state region advance to the regional championships, and USA Gymnastics plans to purchase a ticket for every competitor to attend a session at the Women's National Collegiate Gymnastics Championship.

Adding to the excitement at the NCAA women's championship, 2004 Olympic all-around goldmedalist Carly Patterson and 2008 Olympic team silver-medalist and 2015 NCAA all-around cochampion Samantha Peszek are scheduled to attend and sign autographs at the Fort Worth Convention Center. Peszek is scheduled to sign on Friday with Patterson signing on Saturday.

On the men's side, the Region 5 Men's Junior Olympic Championships holds its competition at French Field House on Ohio State's campus. The event involves approximately 800 boys Levels 5-10 from Indiana, Ohio, Michigan, Kentucky and Illinois. Each gymnast in the competition will receive a ticket to attend the men's NCAA team finals on Saturday evening.

Paul Hamm, 2004 Olympic all-around champion, Brandon Wynn, 2013 world still rings bronzemedalist and Blaine Wilson, 2004 Olympic team silver-medalist are all scheduled to attend the 2016 Men's National Collegiate Gymnastics Championships to sign autographs. Wynn is scheduled to sign autographs on Friday while Wilson and Hamm are set to sign on Saturday.

Is there ever a time that we would void a Level 8 vault, in regards to the spotting

deduction?

Answer:

VOID Vault:

*If Level 8 or any optional gymnast is spotted in pre-flight or support phase.

1.00 Deduction

*if Level 8 gymnast is spotted in the post-flight (encourages coaches to "bump"

the salto in order for the athlete to safely complete more of the BA rotation.

Since it is the first level salto vaults can be performed, the intent is to keep the athletes safer on flipping vaults.

*It is also applicable to any vault performed by Level 8's.

1.50 Deduction:

*If the gymnast is spotted not only in the post-flight, but also during the

landing phase, the spotting assistance on the landing phase deduction of 0.50 will also be applied for a total of 1.50.

- 4. A current officer must be up-to-date with all required reports to be eligible to run for office.




NAWGJ HOTLINE

Gentle Reminder - If you have a problem, please follow the chain of command! To ensure we have the best communication possible and avoid any confusion, please begin by talking with the party closest to the issue at hand:

1. Talk directly to the person using a non confrontational tone.

- Think about your approach Be cautious of your body language Address that person only, don't gossip Is your facial expression telling? What is your tone of voice? Are you choosing the correct words? Are you respecting personal space? Ask questions that will help you to understand the objective information Do not use accusatory language and don't add inappropriate language Make suggestions with gentle encounters ("have you thought about..." "did you consider..." "I hear you say... "Let's think about...") Stick to the facts – no inflection of your opinion should be provided Listen to their concerns Use empathy "I'm sorry you feel that way" Provide objective feedback
- 2. If not resolved, consult with your SJD.
- 3. If not resolved, consult with your RJD.
- 4. If not resolved, consult with NAWGJ National Board member pertinent to the issue.
