Chief Judge	NEW Wording	<u>0.20</u> after warning	<u>Technical</u> verbal cues by coach or teammate(s) to own gymnast. <u>Cues must be heard by judge.</u>
Chief Judge	NEW Wording	<u>0.20</u> after warning	Failure to observe specified warm-up time taken from event score. <u>Applies only to practice of an element(s).</u>
Chief Judge	NEW Deduction	0.20	Unsportsmanlike conduct of gymnast.
Chief Judge	NEW Deduction	0.30	Use of supplemental support * Unauthorized or additional mats * Unauthorized springboard * Springboard or mount mat/block on unauthorized surface * Use of hand placement mat for Vault
Chief Judge	NEW Deduction	0.30	Using incorrect apparatus specifications, including incorrect spring configurations.
